

The Term & Condition of the contract-

1. The contract will be valid for a period of five years from the date of entering into the contract subject to satisfactory delivery of the service.
2. The SJTA reserves the right to extend/ cancel the contract giving one month notice to the service provider.
3. The service provider will have to provide cable connection, setup box, remote, adopter, dish antenna & other ancillary items for viewing of the TV free of cost at the time of installation.
4. The wires & setup boxes shall be maintained in working condition by the Cable TV service provider & no extra payment will be made for any parts/maintenance services during the contract period.
5. Complains regarding interruption of cable TV services shall be attended to on the same day.
6. **The service provider should quote the list of channels in the pack & the monthly rental for the same.**

7. All the channels free to air should be provided free of cost.
8. All the applications in the proforma prescribed above should be submitted within 27/9/23 by 5.00 PM vide Courier/ registered post/ speed post only. Applications received after the due date & time will not be taken into consideration.
9. The quotations will be opened on 28/9/23 at 11.00 AM in presence of the applicants.
10. The service provider should list out all terms & conditions of providing service in their application.


