



**GENERAL TERMS & CONDITIONS**

1. All applications should be accompanied with application fee of Rs.5,000/- (Non-refundable) and EMD @ 1% of the total cost of Televisions to be supplied (refundable to unsuccessful bidders). Application fee should be paid in shape of Bank Draft / Banker's Cheque in favour of Administrator, Shree Jagannath Temple, Puri. EMD in shape of N.S.C. / POTD / POSB / KVB / Time Deposit in any Nationalised Bank should be pledged in favour of Administrator, Shree Jagannath Temple, Puri.
2. One sealed envelope superscribed as "TECHNICAL BID" will contain only the Technical Specifications of the indented item along with the brochure.
3. A second envelope superscribed as "FINANCIAL BID" will contain only the financial bid in which price and any other information, which has financial implications, will only be given.
4. Both the above sealed envelopes are to be kept in a main envelope, superscribed as "TENDER DOCUMENT FOR SUPPLY OF SMART LED TELEVISIONS".
5. The Technical Bid should accompany complete specification, Manufacturer's name, Address and Technical Literature of the equipment along with necessary photograph of the item to be supplied.
6. Cost of the items should be mentioned clearly in the Financial Bid only.
7. The bidder shall submit his price bid/offer in Indian Rupees and payments under this contract will be made in Indian Rupees.
8. The rates quoted should be inclusive of all taxes including transportation, installation etc.
9. Details of after-sales service offered are to be made clear.
10. As the time is the essence of the contract, DELIVERY PERIOD mentioned in the purchase order should be strictly adhered to.
11. The Supplier shall take all precautions not to disclose, divulge and / or disseminate to any third party any confidential information, propriety information on the Client's business or security arrangements of the Client.
12. The procurement of Smart LED TVs as mentioned in the tender document is one time. The quantity mentioned in the tender is tentative and may increase or decrease at the sole discretion of the competent authority of the client.
13. The Smart LED TVs are to be delivered & installed at our Bhakta Nivases situated in Puri Town, Puri, Odisha.
14. The competent authority of the Client reserves the right to accept or reject any or all the tenders in part or in full, without assigning any reason thereof.
15. The Client reserves the right to relax/amend/withdraw any of the terms and conditions contained in the tender document without assigning any reason thereof.
16. The Supplier shall be responsible for good behaviour and conduct of its workers.

18. The Supplier shall ensure that the work is executed in best workmanship and the smart LED TVs provided to Client is in Conformity with the Specifications as per the tender document.
19. The Supplier shall abide by all laws, as applicable from time to time and ensure that all such Laws are complied by the Supplier in provision of the terms of the Contract.
20. **All the Smart LED TVs supplied by the Supplier in Client's premises shall carry a mandatory minimum warranty of One YEAR from the date of installation and commissioning.**
21. In case of any defect found within one year from the date of supply / installation, items should be repaired free of cost and if repair is not possible the same should be replaced with a new one.
22. **Upon receipt of notice from the office for defective material, the Supplier shall within 7 days of receipt of the notice, replace the defective materials, free of cost at the destination.**
23. Discounted offers if any should be mentioned clearly in the financial bid only.
24. The Supplier shall present the invoice after successful delivery and installation of Smart LED TVs to Client. The Client shall make all endeavors to make payments within 30 days from the receipt of invoice.
25. The Contract cost shall be final and binding. **No price escalation shall be entertained by the Client on any account whatsoever.**
26. **All payment shall be made in Indian Currency by means of e-payment.**
