

Terms and Conditions

1. The rates should be quoted in percentage of excess/less on the BOQ amount in BOQ last page.
2. Contractor will be responsible for payment of royalty and all other taxes as per Government norms.
3. The tenderer has to furnish attested true copy of contractor's license, GST Registration certification and IT Pan Card along with the tender failing with the tender is liable for rejection.
4. No Departmental materials will be supplied to the contractor for the work unless otherwise specified.
5. The contractor should be fully liable to indemnify the department for any compensation under workmen Compensation Act.
6. In case of backing out any by any Contractor, the EMD deposited along with the tender will be forfeited.
7. For the purpose of jurisdiction in the event of dispute if any the contract should be deemed to have entered from state of Orissa it is agreed that neither party to this contract nor the agreement will be competent to bring suit at any place outside State of Odisha.
8. The tenderer shall have to abide by the CPWD safety code introduced by Government of India.
9. The Contractor will abide by the fair wages clause as introduced by the Government.
10. The Contractor should arrange at his own cost necessary tools and plant required for efficient execution of the work and rates quoted should be inclusive of the hire and running charges of such plants and cost of consumables.
11. Subletting of the work is not allowed.
12. Every tenderer is expected to inspect the site for the proposed work before quoting his rate.
13. Conditional tender is liable for rejection.
14. Letter etc. found in the tender box for raising or lowering of the rates in connection with the tender will not be considered.
15. No escalation will be paid due to rise of materials and labour rates.
16. Under no circumstance interest is chargeable for dues payable if any for the work to the Contractor.
17. Additional performance security shall be deposited by the successful bidder when the bid amount is below 5%-No APS, from 5% and above and below 10%-50% of the differential cost and from 10% and above-150% of differential cost of bid amount in shape of DD in favour of Chief Administrator, Shree Jagannath Temple, Puri.
18. In case delay in work due to any unavoidable reason, the contractor should immediately bring the notice of the Temple Administration in writing which may be considered for extension of agreement period.
19. All the items of work executed should confirm to the OPWD code specification.
20. During execution of work the instruction of authorized Engineers of Temple Administration should be meticulously carried out.


