Terms and condition

1. The bidder shall enclose the photo copies of PAN and up-to-date GST clearance certificates.
2. Each bidder shall submit tender of individual items as mentioned in this advertisement as Annexure-I with tentative date/days for the tour.
3. The bid price shall include Train fare (3 Tier A/C), Bus fare/ Transportation charges, price for food (Tea, Breakfast, Lunch, Tiffin, Dinner and Mineral Water etc.), Twin or Triple share Accommodation charges in A/C Rooms at each Tour places, Guide charge, Entry tickets, if any or any govt. duty for each individual.
4. TAX/GST and any other local taxes should be clearly mentioned separately in terms of percentage and amount in the price list.
5. Conditional Tenders (like alternative price offers etc.) are liable to be rejected. In the event of acceptance, the decision of the authority shall be final.
6. The authority reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever.
7. The successful bidder shall be paid up to sixty percent of the total cost as an advance and balance shall be paid after completion of the successful journey.
