The same will be opened on dt.08/11/21, at 5 PM in presence of the bidders or their authorized representatives.

The intending firm / stockist / Distributor should quote the maximum discount rate on M.R.P. of branded medicines to be supplied in Financial Bid. The following documents are to be submitted along with the Technical Bid.

- 1. Valid Drug License from Competent authority.
- 2. GSTIN Registration Certificate from Competent Authority.
- 3. PAN Card Copy
- 4. Income Tax Returns of last 3 (Three) Financial Years.

Both Bids should be submitted in the separate sealed packet indicating technical Bid & Financial Bid on the top of the envelope. Both the Technical Bid & Financial Bid envelopes should be enclosed in a bigger envelope superscribed 'Quotations for supply of Medicines to SJTA'. The financial bid will be opened only when the technical bid of the bidder is found eligible.

The Supplier / Stockist / Distributors must fulfil the following terms & conditions and execute an agreement for supply of medicine if quotation is accepted.

#### **Terms & Conditions:**

- 1. Branded medicines of reputed manufacturers are required to be supplied as per indent.
- 2. Supply of the quoted medicines should be of self contained life of minimum 1 and ½ years except specified self life less than that period.
- 3. Supplied medicines left unutilized within 3 to 6 months of expiry are to be replaced with fresh stock.

5. The firm should take back unutilized medicines having expiry date of minimum 6 months.
