TENDER CALL NOTICE

Shree Jagannath Temple Administration, Puri invites sealed tenders in prescribed schedules from experienced firms/individuals for the following works. The prescribed schedules will be available in the office of SJTA during the working hours on payment of Rs.1,000/-(Rupees one thousand) only plus GST@18% per set of schedule (non-refundable) till dated 02.03.2023.

- **Job-1:** (a) Supply of 57 nos. of manpower per day for cleaning and washing of temple floor area at different locations of BAHARA BEDHA excluding Ananda Bazar.
 - (b) Supply of 33nos. of manpower for cleaning of BHITARA BEDHA.
- Job-2: Supply of 50 nos. of manpower per day for cleaning and washing at ANANDA BAZAR.

The tenders complete in all respects and duly signed should reach the Temple Office on or before 4 p.m. of dtd.03.03.2023 which will be opened on the same day at 5 p.m. in presence of the tenderers or their authorized representatives.

The Service Providers/Firm/Contractors who fulfill the following criteria are eligible to apply and also they should enclose the following relevant certificates/photo copies in their support to participate in tender without which their tender may not be considered (in respect of job No. 1 & 2 above).

Eligibility Criteria

- 1. The bidder must be registered under Company Act 1956 or Indian Partnership Act.
- 2. Firms/individuals having at least 5 years of experience of cleaning and sanitation work in the Govt. Department with performance certificate.
- 3. Having registration under PF & ESI.
- 4. Up-to-date GST clearance certificates.
- 5. Labour license certificate.
- 6. PAN Card.
- 7. An affidavit to the effect that no criminal case is pending with the police against the Firm.
- 8. Solvency certificate of not less than rupees one crore from the Revenue Deptt. Govt. of Odisha should be in the name of owner or organization.
- Copy of the Income Tax Returns filed and audit certificate for the last five consecutive financial years upto Assessment Year 2022-23 certified by the Chartered Accountant.
- 10. The Annual Turnover for the Assessment Year 2022-23 of the agency not less than rupees one crore.

- 11. If the quotated rate is found same then priority will be given to the party who has successfully served any temple under the control of the Endowment or Government of Odisha.
- 12. The service charges quoted by the agency in reasonable rate.
- 13. The bidder must be registered under ISO 9001:2015, ISO 45001:2018, ISO 14001:2015
- 14. Deposit of EMD amounting to Rs.50,000/- (Rupees fifty thousand) only duly pledged in favour of the Chief Administrator, Shree Jagannath Temple, Puri.
- 15. The decision of the Temple Authority is final for selection of the bidder.

Shree Jagannath Temple Administration shall not be liable for any postal delay. The authority reserves the rights to accept or reject any or all the tenders without assigning any reason whatsoever. The participants may visit the Temple premises on their own arrangement during working hours and may contact the Temple Supervisor for the purpose.
