
**Tender Call Notice No.03/2020 (Ele.)**

The tenderer should furnish the credential certificate with same type work in hand. The contractor should furnish valid GST , PAN Card & EMD of 1% on the estimated cost shall be deposited through D.D. in favour of Chief Administrator, Shree Jagannath Temple, Puri. The quantity of machines may vary during the time of AMC period. The tenderer should have minimum 3 years of work experience certificate in Govt. of Odisha or public sector undertaking, ESIC registration certification, PF registration.

The tenders will be opened at 4.30P.M. on the same day in presence of the participants or their authorised representatives. 




