

1. Personal accident cover with medical extension to the work men working in Ratha Khala located near Shree Jagannath Temple Office, Puri against any injury to cover medical expenses and unnatural death sustained during progress of work from **03.05.2022** to **30.06.2022** per person **Rs.5,00,000/-** maximum **10 persons**.
2. Insurance coverage to the devotees/ pilgrims/ sevaks and temple employees within Shree Gundicha Temple for **9 days** from **02.07.2022** to **10.07.2022** for unnatural death / accidental death / stampede / terrorist attack per person **Rs.5,00,000/-** maximum **10 persons**.
3. 
